1. Call to Order

The meeting was called to order at 6:00 p.m. by Chair Rudy Lucero.

6. Approve Minutes of April 9, 2026 Board Meeting

A. Claims Paid on April 23, 2026

Monica Burns reported that the transfers from the Unassigned Reserve to the Capital Asset Reserve and the General Reserve, as designated in the Board-approved revised budget, had been completed and were included in the financial report. The Board reviewed the financial report and the claims paid on April 23, 2026.

9. Fire District's Sustainability Ad Hoc Committee

10. Yolo County Fire Safe Council

A. Updates

Commissioner Hulsman reported that the following items were discussed at the last Fire Safe Council meeting: the Bio Char Kiln; the Knoxville-Blue Ridge Fire Safe Council; the chipper program; burning and grazing activities on Highway 128; and the possibility of returning to in-person meetings, for which there was little interest.

B. Yolo Prescribed Burn Association

A. Office Report – Chief Lawrence reported that:

- a. Commissioners Lucero, and Schwenger still need to complete Ethics Training.
- b. Commissioners Burns still needs to complete Sexual Harassment Training.
- c. Set a meeting date with the Budget Committee board members, Rudy Lucero and Barry Burns, for May 29, 2026 at 9:00 am.

B. Building & Maintenance Report

- a. Using proceeds of renting the Community Hall, a new refrigerator, stove, stove hood and chairs were purchased for the hall.
- b. Engine 219 is undergoing major repairs.


C. Chief's Report – Chief Lawrence reported:

- a. He has applied for the 2026-27 CalFIRE VFC grant.
- b. He is considering establishing an independent PulsePoint account for the District, which would cost between \$800 and \$1,600, depending on whether other local fire districts participate in the account.
- c. The District will undergo an Insurance Services Office (ISO) review, and he has a meeting scheduled with the ISO evaluator on June 2, 2026.
- d. The new firefighter, Nicolas Hernandez, started on May 5, 2026.
- e. An employee will be taking the Driver/Operator Course offered through Yuba College in Marysville, California.
- f. Calls have been fairly steady, and the first grass fire of the season occurred two days ago.

12. Adjournment


A motion was made by Commissioner Burns and seconded by Commissioner Hulsman to adjourn the meeting at 6:22 p.m.
