 - a. Chief Lawrence presented the GL worksheet to the Board for their review.
 - b. Chief Lawrence reported that the new Yolo County accounting system, for which Yolo County will now require all Special Districts to input their claims, generate their reports, create deposits and journal entries, will require extra administrative hours. Additionally, he pointed out that all the existing account codes will be changing.
- B. Building & Maintenance Report
 - a. Chief Lawrence reported that the HVAC motor failed and had to replaced just prior to the Commissioner's meeting.
- C. Chief's Report
 - a. Chief Lawrence reported:
 - i. That the number of fires and calls are increasing with one fire call sustaining a high-cost loss.
 - ii. That the fuel tanks are in place and ready for use which will save the District over \$1.00 per gallon for the cost of gas and diesel.
 - iii. That the Volunteer's held a very successful 4th of July BBQ and fireworks event.
 - iv. That the National Night Out will be on the 1st Tuesday in August.
 - v. That EFPD is working on I-MCI (Intentional Mass-Casualty Incident) trainings with Yocha Dehe Fire Department, Yolo County Sheriffs and the school district. A grant is being worked on to obtain the appropriate safety gear for an active shooter incident.
